Fairview Ave Storm Sewer Junction Chamber Installation

Background

The Village maintains a network of storm sewer pipes throughout town that include pipes made from corrugated metal pipe (CMP), reinforced concrete pipe (RCP), vitrified clay pipe, and polyvinyl chloride (PVC) all various sizes and age.

The storm sewer outfall pipe from the Old Grove Pond is a 42" diameter CMP that flows storm water from the pond and surrounding street storm sewers into the Sugar Creek water way that has been in service since the mid 1960's. The CMP from the pond and storm sewers from the surrounding streets of Fairview Ave., Apple Ln., and Cherry Ln., combine with the pond outfall pipe in a blind connection across the street from the Fairview Sanitary Lift Station (see enclosed photo). This junction has been failing over recent years causing a sink hole in the open lot between 1127 and 1135 S Fairview Ave. Village Utilities Division crews have made various repairs over the past few years but a larger more permeant repair is needed.

Staff investigated different repair options from; full replacement of the storm sewer, spray lining the pipe, to installing a junction chamber in place of the blind connections eliminating the buried joints and gaining an access point for future maintenance of the storm sewer. The decision was made to install a junction chamber due to the benefits of gaining a maintenance access point, eliminating the joints, and a lower cost. The cost of installing the junction chamber was significantly lower than full replacement and spray lining and provided the benefit of access and less disruption to the neighborhood.

Request for Proposals

To expedite construction, the Public Works Department directly solicited proposals from four pre-selected qualified contractors who have successfully worked on previous Village projects/contracts. Documents and a scope of work were sent to four area firms who can perform such work. Two of the four firms submitted a proposal.

The following two firms submitted proposals:

Discussion


All proposals were checked to ensure that the contractor was meeting the proposed scope and providing the needed and necessary equipment to safely and properly complete the job. The lowest responsible proposal for the items requested is Martam Construction Inc. of Elgin, IL. They have performed numerous projects like this for the Village in recent years all to the satisfaction of the Village. Martam Construction Inc. is considered a reliable, responsive vendor.

Funding for this work will be realized in the Water/Sewer Capital Reserve Fund RM PROG 10 Sewer Maintenance and Improvements.

Recommendations:

The Utilities Division requests that we waive the formal bidding process and accept the lowest, responsible proposal for the Fairview Avenue Storm Sewer Junction Chamber Installation to Martam Construction Inc., of Elgin, IL and authorize a purchase order in an amount not to exceed \$54,000.00 at the October 6, 2023 Village BoT meeting.

This agreement is made this 6th day of October, 2022 by and between, and shall be binding upon, the Village of Lombard, an Illinois Municipal Corporation hereinafter referred to as (the "Village") and Martam Construction Inc. of Elgin, IL hereinafter referred to as (the "Contractor").

Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, and herein, the Contractor agrees to sell and install and the Village agrees to pay for the following described items and the installation of the same as set forth in the Contract Documents:

Provide labor, equipment and materials for the excavation and installation of a junction chamber for the Fairview Avenue Storm Sewer in an amount not to exceed \$54,000

- 1. This Contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:
 - a. Request for Proposal for Fairview Avenue Storm Sewer Junction Chamber Installation consisting of the following:

- 2. The Village agrees to pay, and the Contractor agrees to accept as full payment for the items, and installation of the same, which are the subject matter of this Contract, in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.
- 3. Risk of loss, destruction or damage of or to goods under this Contract shall be on contractor until installation and acceptance of the goods by the Village.
- 4. Contractor shall not delegate the duties involved in the performance of the installation services which are the subject matter of this Contract without the written approval of the Village.
- 5. The Contractor represents and warrants that it will comply with all applicable Federal, State and local laws concerning prevailing wage rates regarding installation services provided under this Contract and all Federal, state and local laws concerning equal employment opportunities.
- 6. Time is of the essence of this Contract and Contractor agrees to achieve completion of the work order within the Contract time by all proper and appropriate means including working overtime without additional compensation.
- 7. In executing this Contract, Contractor agrees that it has examined the site of the work and the conditions existing therein, has examined the Contract Documents and taken and compared field measurements and conditions with those Documents.
- 8. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
- 9. Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.
