AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS "A/B-III" LIQUOR LICENSE CATEGORY

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor licenses, contained therein, to read as follows:

Class "A/B-III" - 10
