**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER
OF AVAILABLE LIQUOR LICENSES IN THE
CLASS “A/B-III” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-III” liquor licenses, contained therein, to read as follows:

Class “A/B-III” – 10

SECTION 3: That the decrease in the number of Class “A/-B-III” liquor licenses as set forth in Sections 1 above is a result of Claim Jumper Acquisition Company LLC d/b/a Claim Jumper Restaurant no longer conducting business at 92 Yorktown Center.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
