- Prices exclude any and all required plant or field testing.
- Prices are valid for 10 calendar days from the date of quotation. Customer must notify K-Five within 10 days if Buyer wishes to purchase material. Any confirmations outside the allotted 10 days will be subject to price review and change, if necessary.
- Asphalt must be purchased from the plant, in order to dump broken asphalt or millings. Broken asphalt and millings must be clean, and no petromat is accepted.
- K-Five shall have no liability for delay or failure to make shipments, as a result of strikes, labor problems, severe weather conditions, casualty, mechanical breakdowns or other conditions beyond K-Five's reasonable control.
- The Buyer will be responsible for all costs of collection, including reasonable attorney's fees, costs of suit and preparation, and other costs and expenses paid or incurred endeavoring to collect.
