Please find the following items for Village Board consideration as part of the August 18, 2016 Board meeting:

1. A Resolution accepting the 2015 Historic Survey (Survey of Additional Sites).
2. The 2015 Historic Survey (Survey of Additional Sites) prepared by Douglas Gilbert Architect.

The 2015 Historic Survey is a survey of 41 additional sites to the official survey approved in 2014. The 2015 Historic Survey was completed in early spring 2016. The Historic Preservation Commission reviewed and corrected the survey at their April 19, 2016 meeting. The findings of the survey are for planning and information gathering purposes. Property owners may wish to apply to list their property on the National Register of Historic Places and/or a Village designated landmark. Those processes are completely voluntary.

The survey will be placed on the Village's website, after a positive vote from the Village Board of Trustees. Members of the public are encouraged to view the survey.

The Historic Preservation Commission unanimously recommended acceptance of the historic survey on July 19, 2016. Please place this resolution on the August 18, 2016 Board of Trustees agenda.

**A RESOLUTION ACCEPTING THE 2015 HISTORIC SITES AND  
STRUCTURES INVENTORY ACCORDING TO SECTION 32.079(B)**

WHEREAS, an Historic Preservation Commission was established to have the authority to recommend the designation or rejection of sites having a special historical or community interest or value, thereby making the designation as a “landmark site” or “landmark district”; and

WHEREAS, the Historic Preservation Commission shall have the authority to conduct a survey of sites within the village which may be eligible for said designation and maintain a register thereof. This list may include single structures or sites, portions of structures, groups of structures, man-made or natural landscape elements, works of art, or integrated combinations thereof; and

WHEREAS, said survey of sites was conducted by Douglas E. Gilbert Architect, Preservation Architecture and Consulting and was submitted to the Historic Preservation Commission on July 19, 2016; and

WHEREAS, the Historic Preservation Commission requests that the Village Board of Trustees concur with the acceptance of the survey of sites, as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:
