## ORDINANCE NO. 7263

## AN ORDINANCE AMENDING TITLE XI, CHAPTER 121, SECTION 121.08 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE TAXI SUBSIDY PROGRAM

- **BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:
- **SECTION 1:** That Title XI, Chapter 121, Section 121.08(C) of the Lombard Village Code is amended by inserting the words ", subject to subsection (J) below," between the words "That" and "senior" as contained in the first line thereof.
- SECTION 2: That Title XI, Chapter 121, Section 121.08(D) of the Lombard Village Code is amended by inserting the words ", subject to subsection (J) below," between the words "That" and "the" as contained in the first line thereof.
- <u>SECTION 3:</u> That Title XI, Chapter 121, Section 121.08(G) of the Lombard Village Code is amended by inserting the words ", subject to subsection (J) below," between the words "That" and "the" as contained in the first line thereof.
- <u>SECTION 4:</u> That Title XI, Chapter 121, Section 121.08 of the Lombard Village Code is amended by adding new subsections (J) and (K) thereto, which shall read in their entirety as follows:
  - "(J) Effective January 1, 2017, no new photo identification cards, as provided for in subsections (C) and (D) above, shall be issued by the Village, and no new taxi coupons, as provided for in subsection (G) above, shall be issued by the Village; however, any previously-issued taxi coupons may be used, by those individuals in possession thereof, during calendar year 2017.
  - (K) Effective January 1, 2018, this Section 121.08 is repealed in its entirety."
- **SECTION 5:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
