IEPA Public Water Supply Loan

The Village previously applied and received approval from the Illinois Environmental Protection Agency for funds through the Public Water Supply Loan Program (PWSLP). The Village received funding in the amount of \$8,172,392, which was contained in the Loan Agreement approved on May 18, 2016. The funding was provided for the Roosevelt Road Watermain Lining Phase I, Roosevelt Road Watermain Lining Phase II and Transmission Main (Civic Center to South Booster) projects. At their June 16, 2016 meeting, the Village Board adopted Ordinance No. 7225 amending the requested loan amount to \$12,050,354.16.

Based upon recent discussion between the Illinois Environmental Protection Agency and Village staff, it was determined to not amend the original loan amount, but rather to apply for a second loan instead. The second loan will be issued at a lesser interest rate of 1.76% as opposed to the originally agreed upon interest rate of 1.86%.

Please present this Ordinance for Village Board approval at their September, 1, 2016 meeting. Staff is requesting a waiver of first reading.
