Special Event Liquor Licenses for Punky's Pub, Shannon's Deli, and Babcock's Grove House for the 2016 Chicago Bears versus Green Bay Packers Game and one potential Chicago Cubs Playoff Game and one potential Chicago Cubs World

Series Game

Lombard Town Centre (LTC) would like approval to host up to three (3) viewing events in 2016. The first event is a Bears versus Packers game on October 20, 2016 at 7:25 p.m. The next two events are tentative, assuming the Chicago Cubs advance into the playoffs and/or the World Series. Those dates and times are not set, however, seeing as there may not be a Village Board meeting before such event, LTC and staff is requesting approval of all three events at this time.

The ordinances would allow for the sale and consumption of alcoholic beverages with the viewing event. The events would be similar in design and operations as past viewing events.

Attached are two ordinances for the viewing events:

- AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION WITH A TEMPORARY EVENT AT 11 AND 16 SOUTH PARK AVENUE AND 101 WEST St. CHARLES ROAD, ON OCTOBER 20, 2016
- 2. AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION WITH TEMPORARY EVENTS AT 11 AND 16 SOUTH PARK AVENUE AND 101 WEST St. CHARLES ROAD, BETWEEN OCTOBER 4, 2016 AND NOVEMBER 3, 2016

Should the aforementioned Ordinance be approved, staff will work with the relevant parties (i.e., Punky's Pub, Shannon's Deli, Babcock's Grove House, and Lombard Town Centre), to finalize the

plans for any such viewing events. Issues to be finalized include specific dates and times, event conflicts, Village staff labor/staffing, equipment availability, and outdoor space availability.

ACTION REQUESTED

This item is being placed on the September 15, 2016 Village Board of Trustees meeting for consideration and approval. Staff recommends waiver of first reading.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B)
OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES,
PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION
WITH A TEMPORARY EVENT AT 11 AND 16 SOUTH PARK AVENUE AND 101
WEST ST. CHARLES ROAD,
ON OCTOBER 20, 2016

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is amended by adding a new subsection (7) thereto, effective upon the adoption of this Ordinance through 11:59 p.m. on Thursday, October 20, 2016, which shall read in its entirety as follows:

"(7) In light of the fact that Topaz RG, LLC d/b/a Babcock's Grove House, located at 101 West St. Charles Road, Shannons on Park, Inc. d/b/a Shannon's Deli, located at 11 South Park Avenue, and Bill and Punky's Step Up Inn, Ltd. d/b/a Punky's Pub, located at 16 South Park Avenue (hereinafter collectively the "Liquor Licensees"), will be holding one (1) temporary event for the viewing of one (1) Chicago Bears regular season game, on October 20, 2016, should the Chicago Bears play on said date, said Liquor Licensees shall each be eligible for a Class "J" liquor license, despite the fact that said Liquor Licensees are for-profit business entities, for the sole purpose of selling alcoholic beverages for consumption in a designated and secured area adjacent to each of said licensed premises, to be approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code, beginning two (2) hours prior to the start of one (1) Chicago Bears regular season game, on October 20, 2016, should the Chicago Bears play on the said date, and terminating thirty (30) minutes after the conclusion of said regular season game. The liquor licenses to be issued under this subsection (7) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by No liquor license shall be issued under this the Liquor Licensees. subsection (7) until such time as each of said Liquor Licensees obtains the necessary temporary event permit under Chapter 110 of the Village Code and complies with all requirements and conditions thereof, including,

without limitation, the insurance, bond and indemnification requirements of Chapter 110 of the Lombard Village Code in regard to temporary events.

In addition, if such Liquor Licensees are issued liquor licenses by the Local Liquor Commissioner under this subsection (7), said Liquor Licensees shall, notwithstanding any other provisions of this Chapter 112, be subject to the following additional requirements:

- (a) The sale of alcoholic beverages shall occur within the buildings on the premises for which the Liquor Licensees each have a valid non-Class "J" liquor license (the "Licensed Premises") or outdoors, but within ten (10) feet of the main entrance of the Licensed Premises;
- (b) The sales and dispensing of alcoholic beverages in pitchers is prohibited;
- (c) No more than two (2) alcoholic beverages may be purchased by any person at the same time;
- (d) All individuals purchasing or consuming alcoholic beverages shall be required to wear a wristband, to indicate that they are at least twenty-one (21) years of age, and the Liquor Licensees shall be responsible for the verification of age and distribution of said wristbands;
- (e) Alcoholic beverages, that are sold for consumption outside of the Licensed Premises, must be served in plastic cups with a capacity of no more than sixteen (16) ounces;
- (f) If the temporary event requires the use of the Village controlled public right-of-way and the temporary event necessitates the Village's providing of Police, Public Works and/or technical audio-visual services (the "Village Services"), the Liquor Licensees shall reimburse the Village for the costs incurred by the Village relative to said Village Services, within fifteen (15) days of the Village providing the Liquor Licenses with a bill for said Village Services. In the event said bill is not paid within said fifteen (15) day period, said bill shall accrue interest at the rate of two percent (2%) per month, with the minimum interest amount being for a one (1) month period."

SECTION 2: That, effective at 11:59 p.m. on Thursday, October 20, 2016, Title 11, Chapter 112, Section 112.18(B)(7) of the Lombard Village Code, as set forth in Section 1 above, is hereby repealed, without need for any further action by the President and Board of Trustees.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is amended by adding a new subsection (8) thereto, effective upon the adoption of this Ordinance through 11:59 p.m. on Thursday, November 3, 2016, which shall read in its entirety as follows:

"(8) In light of the fact that Topaz RG, LLC d/b/a Babcock's Grove House, located at 101 West St. Charles Road, Shannons on Park, Inc. d/b/a Shannon's Deli, located at 11 South Park Avenue, and Bill and Punky's Step Up Inn, Ltd. d/b/a Punky's Pub, located at 16 South Park Avenue (hereinafter collectively the "Liquor Licensees"), will be holding two (2) temporary events for the viewing of one (1) Chicago Cubs non-World Series playoff game and one (1) Chicago Cubs World Series game, between October 4, 2016 and November 3, 2106, should the Chicago Cubs make the playoffs and the World Series, said Liquor Licensees shall each be eligible for a Class "J" liquor license, despite the fact that said Liquor Licensees are for-profit business entities, for the sole purpose of selling alcoholic beverages for consumption in a designated and secured area adjacent to each of said licensed premises, to be approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code, beginning two (2) hours prior to the start of two (2) temporary events for the viewing of one (1) Chicago Cubs non-World Series playoff game and one (1) Chicago Cubs World Series game, between October 4, 2016 and November 3, 2106, should the Chicago Cubs make the playoffs and the World Series, and terminating thirty (30) minutes after the conclusion of each of said games. The liquor licenses to be issued under this subsection (8) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by the Liquor Licensees. No liquor license shall be issued under this subsection (8) until such time as each of said Liquor Licensees obtains the necessary temporary event permit under Chapter 110 of the Lombard Village Code and complies with all requirements and conditions thereof, including, without limitation, the insurance, bond and indemnification requirements of Chapter 110 of the Lombard Village Code in regard to temporary events.

In addition, if such Liquor Licensees are issued liquor licenses by the Local Liquor Commissioner under this subsection (8), said Liquor Licensees shall, notwithstanding any other provisions of this Chapter 112, be subject to the following additional requirements:

- (a) The sale of alcoholic beverages shall occur within the buildings on the premises for which the Liquor Licensees each have a valid non-Class "J" liquor license (the "Licensed Premises") or outdoors, but within ten (10) feet of the main entrance of the Licensed Premises;
- (b) The sales and dispensing of alcoholic beverages in pitchers is prohibited;
- (c) No more than two (2) alcoholic beverages may be purchased by any person at the same time;
- (d) All individuals purchasing or consuming alcoholic beverages shall be required to wear a wristband, to indicate that they are at least twenty-one (21) years of age, and the Liquor Licensees shall be responsible for the verification of age and distribution of said wristbands;
- (e) Alcoholic beverages, that are sold for consumption outside of the Licensed Premises, must be served in plastic cups with a capacity of no more than sixteen (16) ounces;
- (f) If the temporary event requires the use of the Village controlled public right-of-way and the temporary event necessitates the Village's providing of Police, Public Works and/or technical audio-visual services (the "Village Services"), the Liquor Licensees shall reimburse the Village for the costs incurred by the Village relative to said Village Services, within fifteen (15) days of the Village providing the Liquor Licenses with a bill for said Village Services. In the event said bill is not paid within said fifteen (15) day period, said bill shall accrue interest at the rate of two percent (2%) per month, with the minimum interest amount being for a one (1) month period;
- (g) In light of the fact that the two (2) temporary event dates are unknown as of the date of the Ordinance approving this subsection (8), the Village reserves the right to approve the date of each temporary event, to change the date of each temporary event after the date(s) are determined, and to cancel each temporary event, in the Village' sole and absolute discretion."

SECTION 2: That, effective at 11:59 p.m. on Thursday, November 3, 2016, Title

11, Chapter 112, Section 112.18(B)(8) of the Lombard Village Code, as set forth in
