Pursuant to 5 ILCS 120/2.03, certain notification requirements must be complied with relative to any change in a public body's regular meeting date. Although not specifically mentioned in the aforementioned section of the State statutes, I would suggest that the Village follow said notification requirements relative to the change in the starting time for regular Board meetings. AN ORDINANCE AMENDING TITLE III, CHAPTER 30, SECTION 30.01 OF THE LOMBARD VILLAGE CODE IN REGARD TO REGULAR MEETINGS OF THE VILLAGE BOARD, AND THE STARTING TIME IN RELATION THERETO

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That, effective January 1, 2017, Title III, Chapter 30, Section 30.01 of the Lombard Village Code is amended to read in its entirety as follows:

"§ 30.01 Regular meetings.

- (A) Regular meetings of the Board of Trustees shall be held on the first and third Thursday of each month at 7:00 p.m. in the Board Room of the Village Hall.
- (1) The meeting date, time and place may be changed by the direction of the Board of Trustees, provided legal notice of said change is issued to the public and the news medium pursuant to State statute."

SECTION 2: That the Village Clerk is hereby directed to advise all news medium, that have requested notice of the time and place of Village meetings, of this Ordinance. In addition, pursuant to 5 ILCS 120/2.03, the Village Clerk is directed to publish a notice of the regular meeting starting time change, as set forth in Section 1 above, in a local newspaper. Said notice shall be in the form attached hereto as Exhibit "A" and made part hereof.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
