T.G.I. Friday's - 601 E. Butterfield Rd.

Central Florida Restaurants Inc. d/b/a T.G.I. Friday's located at 601 E. Butterfield currently holds an "A/B-III" liquor license. As part of the liquor license renewal process, staff received an email from Central Florida Restaurants Inc. d/b/a T.G.I. Friday's dated October 4, 2016 advising that they will not be renewing their lease and at the close of business on November 30, 2016 will officially and permanently close. As a result, attached is an ordinance decreasing the Class "A/B-III" liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class "A/B-III" liquor classification current to reflect this change.

### AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor licenses contained therein, to read as follows:

#### Class "A/B-III" - 12

- Section 2: That the decrease in the number of Class "A/B-III" liquor licenses set forth in Section 1 above, is a result of Central Florida Restaurants Inc. d/b/a T.G.I. Friday's no longer conducting business at 601 E. Butterfield Road.
- Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
