SUBJECT: Ordinance Amending Section 50.999 of the Lombard Village Code

Title V of the Lombard Village Code provides for the use of the Village's sanitary sewer system. Contained in the Code are requirements for compliance with the USEPA requirements for the pretreatment of industrial users of the sanitary sewer system. The Code specifically provides for the monitoring and reporting of industrial pretreatment.

The Village recently determined that the penalty provision contained in Section 50.999 was not consistent with Federal and State laws, which require the penalty for violations of the pretreatment program result in a minimum penalty of \$1,000 per occurrence. The attached Ordinance amends section 50.999 of the Lombard Village Code to be in compliance with 40 CFR 403.8(f)(1)(vi)(A) and 35 III. Adm. Code 310.510(a)(6)(A).

I respectfully request that this matter be placed on the Village Board agenda for the March 16, 2017 meeting for consideration.

Staff recommends that the Village President and Board of Trustees approve the Ordinance Amending Section 50.999 of the Lombard Village Code.

ORDINANCE NO.

AN ORDINANCE AMENDING TITLE V, CHAPTER 50, SECTION 50.999 OF THE LOMBARD VILLAGE CODE IN REGARD TO PENALTIES FOR VIOLATIONS OF INDUSTRIAL USER WASTEWATER PRETREATMENT STANDARDS AND REQUIREMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title V, Chapter 50, Section 50.999 of the Lombard Village Code is amended by inserting the following between the first and second sentence of said Section 50.999:

"Notwithstanding the foregoing, any user who has been found to have violated any of the wastewater pretreatment standards and requirements, as set forth in Sections 50.040, 50.055, 50.056, 50.057 or 50.058 of this Code, shall, pursuant to the requirements of, and authority granted by, 40 CFR 403.8(f)(1)(vi)(A) and 35 Ill.Adm. Code 310.510(a)(6)(A), be fined \$1,000.00 for each violation."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
