**SUBJECT:** **Liquor License – Punky’s Pub**  
**16 S. Park Avenue**

Bill and Punky’s Step Up Inn, Ltd. d/b/a Punky’s Pub currently holds a Class “D” liquor license which allows the sale of alcoholic beverages served with the primary purpose of the establishment being the sale of alcoholic beverages with package goods allowed to be sold.

Village staff was advised that Elizabeth Shissler, one hundred (100%) shareholder of the corporation Bill and Punky’s Step Up Inn, Ltd. d/b/a Punky’s Pub, passed away. Village Code Section 112.20(A) states that the estate of the decedent can operate the business under the current liquor license until the expiration of the current license (May 31, 2017) but no longer than six (6) months after the death of the licensee. Village Code Section 112.18(D) states that a liquor license shall terminate whenever fifty percent (50%) or more of the ownership interest changes from that shown on the original license application. These Sections of Village Code would require the termination of the current liquor license and the new ownership, The Estate of Elizabeth Ann Shissler, Jeanine M. Gray Independent Executor, making application for a new liquor license. The change in ownership would become effective concurrent with the new licensing term or June 1, 2017.

Attached is an ordinance decreasing and increasing the Class “D” liquor license category by one, effective June 1, 2017, to reflect the ownership change.

The petitioner is requesting a waiver of first reading in order to allow sufficient time to provide notification to the State of Illinois of the ownership change.

**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "D" liquor license category, contained therein, to read as follows:

Class "D" – 2

This decrease in the number of Class "D" liquor licenses reflect the termination of the Class "D" liquor license issued to Bill & Punky's Step Up Inn, Ltd. d/b/a Punky's Pub located at 16 S. Park Avenue due to a 100 % ownership interest change.

SECTION 2: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "D" liquor license, contained therein, to read as follows:

Class "D" - 3

This increase in the number of Class "D" liquor licenses reflect the issuance of a new Class "D" liquor license to Bill & Punky's Step Up Inn, Ltd. d/b/a Punky's Pub located at 16 S. Park Ave., Lombard, IL.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
