Lombard Liquor - 420 W. 22<sup>nd</sup> Street

Lombard Liquor Inc. d/b/a Lombard Liquor currently holds a Class "F" liquor license. The primary purpose of the establishment is the packaged sale of alcoholic liquors, not for consumption on the premises.

The Village of Lombard has received a request from the prospective new owner, Totra Maa Lombard Inc. d/b/a Lombard Liquor, who has applied for a Class "F" liquor license to operate at the same location. Attached is an ordinance decreasing and increasing the number of Class "F" licenses by one to account for the new ownership.

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

<u>Section 1:</u> That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows:

Class "F" - 4

This decrease in the number of Class "F" liquor license entries reflects the ceasing of business by Lombard Liquor Inc. d/b/a Lombard Liquor located at 420 W. 22<sup>nd</sup> Street and the termination of the Class "F" liquor license issued to Lombard Liquor in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein, to read as follows:

Class "F" - 5

This increase in the number of Class "F" liquor license entries reflects the issuance of a new Class "F" liquor license to Totra Maa Lombard Inc. who will be operating the business commonly known as Lombard Liquor located at 420 W. 22<sup>nd</sup> Street, Lombard, IL.

<u>Section 3:</u> This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
