This Resolution upon approval by the President and Board of Trustees and subsequent approval by IDOT authorizes the use of MFT funds for the following programs: Funding for the purchase of Salt, Calcium Chloride and Salt Brine for FY 2018 and over-time wages related to snow removal in 2018.

This Resolution appropriates the use of four hundred twenty thousand dollars and no cents (\$420,000.00) of Motor Fuel Tax Funds from the Village's MFT account.

BE IT FURTHER RESOLVED, that the Clerk shall immediately transmit two certified copies of this resolution to the district office of the Department of Transportation, at Schaumburg, Illinois.
