Ordinance Amending Title 11, Chapter 112, Section 112.13(A)

Royal Liquor & Wine - 243 S. Westmore/Meyers Rd.

The Village has received a request for a Class "F" liquor license from Shree Sahajanand Inc. d/b/a Royal Liquor & Wine located at 243 S. Westmore/Meyers Road. The primary purpose of the establishment will be a package store which will provide for the sale of alcoholic liquors not for consumption on the premises. As you will recall, Westmore Liquors permanently ceased business operations on February 15, 2018. Royal Liquor & Wine will occupy their vacated space and will have a similar business model. Their projected opening date is early July, 2018.

Attached is an ordinance increasing the Class "F" liquor license category by one and issuing a liquor license to Shree Sahajanand Inc. d/b/a Royal Liquor & Wine.

The petitioner has requested that first reading be waived due to the Village Board's summer schedule.

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license category contained therein, to read as follows:

Class "F" - 5

This increase in the number of Class "F" liquor licenses reflects the issuance of a Class "F" liquor license to Shree Sahajanand Inc. who will be operating the business commonly known as Royal Liquor & Wine located at 243 S. Westmore/Meyers Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
