Number of Public Passenger Licenses

Village Code Title 11, Chapter 121, Section 121.03 states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

Flat Rate Cab Dispatch, 330 E. Roosevelt Road, Suite 140, Lombard IL and All Star Cab Dispatch, 1124 Algonquin Road, Lake in the Hills, IL had taxicab licenses to operate within the Village of Lombard through June 30, 2018. All Star Cab Dispatch contacted the Village to advise that they were not going to renew their taxicab license due to downsizing. Flat Rate Cab Dispatch has not responded to the Village nor have they paid the renewal fee after being advised on July 19, 2018 that their taxicab license expired and outlined the actions needed to renew their license.

Attached is an ordinance amending Title 11, Chapter 112, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from six (6) to four (4) to accommodate the non-renewal of the aforementioned licensees.

Staff is requesting a waiver of first reading in order to reflect the current number of public passenger licenses.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 121, SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN REGARD TO PUBLIC PASSENGER LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

Village Clerk

There shall be four (4) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the voluntary non-renewal of the license by:

- Flat Rate Cab Dispatch, 330 E. Roosevelt Road, Suite 140, Lombard IL
- All Star Cab Dispatch, 1124 Algonquin Road, Lake in the Hills, IL

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
