BACKGROUND/POLICY IMPLICATIONS:				
A 2010 IGA between the Village of Lombard and the Village of Glen Ellyn provides for the transfer of the roadway to Glen Ellyn on or before January 30, 2018. The Village of Lombard and Village of Glen Ellyn executed the necessary agreements in January 2018l; however the Illinois Department of Transportation has requested a change in the limits of the jurisdictional transfer. The attached Ordinance effectuates the transfer with the modified termini.

SUBJECT: Hill Avenue Jurisdictional Transfer

Background

In October 2010, the Village of Glen Ellyn and the Village of Lombard entered into an intergovernmental agreement that provided funding for the replacement of the Hill Avenue Bridge. The cost of the bridge replacement was estimated at \$2,200,000. The Village of Lombard received Bridge Replacement and Rehabilitation Program (BRRP) funds, which would fund 80% of the project costs. The local match was to be split 50%/50% between Glen Ellyn and Lombard, with a cap of \$300,000 on Glen Ellyn's share.

As part of the IGA, the Village's agreed to amend the existing boundary agreement to place the properties north of Hill Avenue and west of the bridge in Glen Ellyn of the boundary line. The properties have been disconnected from Lombard and are in the process of negotiating annexation agreements. While the Village boundary has been amended and the properties west of the bridge are unincorporated, the roadway and utilities remained with Lombard.

The IGA provided that Lombard would dedicate the Glen Oak Lift Station and all related sanitary sewer utilities at such time as Glen Ellyn extends sanitary sewer the properties currently served by the Glen Oak Lift at such time as the connection is made, but no later than January 30, 2018. Additionally, the IGA provides that the upon the transfer of the Glen Oak Lift Station, Glen Ellyn will accept a jurisdictional transfer of Hill Avenue and all sanitary sewer utilities owned by or under the jurisdiction of Lombard west of the Bridge. The conveyance of the utilities and Glen Oak Lift Station occurred via a bill of sale and are under now owned and maintained by the Village of Glen Ellyn.

Ordinance 7465, which was adopted by the Village Board of Trustees at the January 18, 2018 meeting, sought to transfer the jurisdiction of Hill Avenue west of the west joint of the Hill Avenue Bridge. Glen Ellyn and Lombard adopted companion Ordinances that effectuated the conveyance of the roadway. In accordance with Illinois Statutes and IDOT regulations, the Villages submitted the jurisdictional transfer to the Illinois Department of Transportation on the appropriate Bureau of Local Roads form (BLR 05212). IDOT has requested a modification to the language that defines the area that will be conveyed as part of the jurisdictional transfer. Rather than use the west joint line of the Hill Avenue Bridge, IDOT has required the calculation

to the based upon the closest right-of-way within the corporate limits of Lombard. As such, the Vance Street r-o-w has been used to determine the area subject to the transfer.

The transfer of the roadway was also delayed due to the annexation process in Glen Ellyn. Under State Statutes, Glen Ellyn could not accept the transfer of the roadway until such time as their corporate limits were contiguous to the roadway. With Glen Ellyn annexing properties at 21W180 Hill Avenue and 21W200 Hill Avenue at the October 8, 2018 Village Board of Trustees meeting, the transfer can be perfected.

Recommendation

Staff recommends that the Village Board of Trustees approve AN ORDINANCE APPROVING THE TRANSFER OF JURISDICTION OVER A PORTION OF HILL AVENUE TO THE VILLAGE OF GLEN ELLYN, AND REPEALING ORDINANCE NO. 7465.

AN ORDINANCE APPROVING THE TRANSFER OF JURISDICTION OVER A PORTION OF HILL AVENUE TO THE VILLAGE OF GLEN ELLYN, AND REPEALING ORDINANCE NO. 7465

WHEREAS, pursuant to Section 6.B.ii. of "An Intergovernmental Agreement Between the Village of Lombard and the Village of Glen Ellyn in Regard to the Reconstruction of the Hill Avenue Bridge," dated October 7, 2010, and recorded with the DuPage County Recorder's Office on October 15, 2010 as document number R2010-140097, (the "IGA"), the Village of Lombard ("Lombard") is to transfer title to the Glen Oak Lift Station and all related sewer facilities (the "Lift Station and Sewers") to the Village of Glen Ellyn ("Glen Ellyn") on or before January 30, 2018; and

WHEREAS, pursuant to Section 6.B.iv. of the IGA, upon transfer of title to the Lift Station and Sewers to Glen Ellyn, Lombard is to transfer jurisdiction over that portion of Hill Avenue, from a point fourteen hundred and sixty (1,460) feet West of Vance Street right-of-way to a point nineteen hundred and seventy-five (1,975) feet West of the West of Vance Street right-of-way, as depicted on Exhibit A attached hereto and made part hereof, (the "Hill Avenue ROW") to Glen Ellyn, and transfer title to all sanitary sewer utilities located within the Hill Avenue ROW (the "Hill Avenue Sewers") to Glen Ellyn; and

WHEREAS, the transfer of jurisdiction over the Hill Avenue ROW shall not include the transfer of title to any public water mains located within the Hill Avenue ROW; and

WHEREAS, pursuant to a Bill of Sale approved by the President and Board of Trustees of the Village of Lombard (the "Lombard Village Board") on January 18, 2018, Lombard has transferred title to the Lift Station and Sewers and Hill Avenue Sewers to Glen Ellyn; and

WHEREAS, based on the foregoing, Lombard now desires to transfer jurisdiction over the Hill Avenue ROW to Glen Ellyn, with said transfer of jurisdiction to be accomplished pursuant to the Local Agency Agreement for Jurisdictional Transfer document attached hereto as Exhibit B and made part hereof (the "JT Agreement"); and

WHEREAS, the Lombard Village Board deems it to be in the best interests of Lombard to approve the transfer of jurisdiction over the Hill Avenue ROW to Glen Ellyn pursuant to the JT Agreement;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That the recitals set forth above are incorporated herein by reference, and made part of this Ordinance. SECTION 2: That the transfer of jurisdiction over the Hill Avenue ROW, as more particularly described in the JT Agreement, to Glen Ellyn, pursuant to the JT Agreement, is hereby approved. SECTION 3: That the Lombard Village President is hereby authorized and directed to execute said JT Agreement on behalf of Lombard, and to execute any additional documents in furtherance of said JT Agreement. SECTION 4: That the Village's Director of Public Works is hereby authorized and directed to attach a certified copy of this Ordinance to the original signature copy of the JT Agreement, and to file said fully executed original signature copy of said JT Agreement with the State of Illinois Department of Transportation. **SECTION 5:** That Ordinance No. 7465, adopted on January 18, 2018, is hereby repealed. SECTION 6: This Ordinance shall be in full force and effect from and after its passage and approval, as provided by law. Passed on first reading this day of , 2018. 
