Subject: Main Street Improvements Design Engineering Contract

Main Street Improvements is a new project included within the approved 2019-2028 Capital Improvement Program. The VILLAGE secured federal (STBGP) 2020 construction funding for this project through the DuPage Mayors and Managers Conference. The 2020 construction project budget is \$1,377,500 (\$964,250 STBGP funds, \$413,250 Village funds), with Village budgeted funds of \$158,000 for 2019 design engineering/geotechnical services and \$170,000 for 2020 construction observation/material testing services. Geotechnical and construction material testing services will be provided under separate contracts. The project is scheduled for design in 2019 and construction in 2020. The VILLAGE will create separate professional services contracts awarded in actual fiscal years.

The project consists primarily of asphalt resurfacing between Graham Avenue and Parkside Avenue. Short concrete sections (Wilson Avenue to Graham Avenue, Parkside Avenue to St. Charles Road) will be restriped. Other specific improvements include enhancing the geometric pedestrian corners/crossings at Maple Street, adding traffic signal interconnection at Hickory Street and Madison Street, connecting those two intersections to existing interconnection at Maple Street and Wilson Avenue, and optimizing the traffic signal interconnected corridor from St. Charles Road to Morris Avenue.

A Request for Proposal (RFP) was sent to all eligible firms on both 2018 Design and Resident Engineering Shortlists. Civiltech Engineering was determined by the Public Works selection evaluation team to be the most qualified firm. The contract scope and fee for design engineering and construction observation were negotiated and agreed to by both parties. Since this work will occur in separate fiscal years, this 2019 contract work will be performed for a total design engineering fee not to exceed \$144,869.91 from the CIP Engineering Fund.

Please present the attached agreement and resolution for the contract to the President and Board of Trustees for their review at their regular meeting of January 3, 2019. If approved, please return two original signed copies of the agreement to Public Works for further processing.
