SUBJECT: Request for a Class "A/B-II-VG" Liquor License

Sal's Pizza Pub – 410 W. 22nd Street

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

Sadco One, Inc. d/b/a Sal's Pizza Pub located at 410 W. 22nd Street Road currently holds a Class "A/B-II" liquor license which allows alcoholic beverages served for consumption on the premises of a restaurant.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. Sadco One, Inc. d/b/a Sal's Pizza Pub has decided to voluntarily not renew their Class "A/B-II" license for the upcoming liquor licensing term and Sadco One, Inc. d/b/a Sal's Pizza Pub has applied for a new Class "A/B-II-VG" liquor license.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class "A/B-II" liquor license category by one and increasing the number of entries in the Class "A/B-II-VG" license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 6

This decrease in the number of Class "A/B-II" liquor licenses reflects the voluntary non-renewal of Sadco One, Inc. d/b/a Sal's Pizza Pub located at 410 W. 22nd Street for the July 1 through December 31, 2019 licensing term and the termination of the Class "A/B-II" liquor license issued to Sadco One, Inc. d/b/a Sal's Pizza Pub in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II-VG" liquor license, contained therein, to read as follows:

Class "A/B-II-VG" - 2

This increase in the number of Class "A/B-II-VG" liquor licenses reflects the issuance of a new Class "A/B-II-VG" liquor license to Sadco One, Inc. d/b/a Sal's Pizza Pub located at 410 W. 22nd Street, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
