GroundLevel 105 - 105 W. St. Charles Road

The Village has received a request for a Class "A/B-I" liquor license from GroundLevel 105, LLC d/b/a GroundLevel 105 located at 105 W. St. Charles Road. The restaurant will be a full-service restaurant offering modern American cuisine with full bar service. ## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein, to read as follows:

Class "A/B-I" - 7

This increase in Class "A/B-I" liquor licenses reflects the issuance of a Class "A/B-I" liquor license to GroundLevel 105, LLC who will be operating the business commonly known as GroundLevel 105 located at 105 W. St. Charles Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
