BACKGROUND/POLICY IMPLICATIONS:

Patan Inc. d/b/a Masala located at 801 E. Butterfield Road is no longer conducting business at that location. Lombard BBQ Inc. d/b/a Firewater BBQ N Brew located at 440 E. Roosevelt Road and Duafe I, LLC d/b/a 18/8 Fine Men's Salons-Lombard located at 314 Yorktown are voluntarily not renewing their liquor licenses.

Attached is an Ordinance reflecting a decrease in the number of entries in the Class "A/B-I", "C" and "V" liquor license categories as required by Village Code.

A waiver of first reading is being requested in order to bring the number of licenses available in these liquor categories current to reflect this change.

**SUBJECT:** Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code  
Alcoholic Beverages  
Non-Renewal of Liquor Licenses

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff has completed the renewal process for the January 1 through June 30, 2020 licensing term. The following liquor licensees have voluntarily not renewed their licenses for the current licensing term and no longer possess a valid liquor license and/or are no longer conducting business:

- Patan Inc. d/b/a Masala located at 801 E. Butterfield Road House (no longer conducting business)
- Lombard BBQ Inc. d/b/a Firewater BBQ N Brew located at 440 E. Roosevelt Road (voluntarily not renewing their liquor license)
- Duafe I, LLC d/b/a 18/8 Fine Men's Salons-Lombard located at 314 Yorktown (voluntarily not renewing their liquor license)

Attached is an ordinance decreasing their respective liquor license classifications ("A/B-I", "C" and "V" respectively) by one to account for their non-renewal.

Staff is requesting a waiver of first reading in order bring the number of entries in each liquor classification current.

**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF  
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

**Section 1:** That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor licenses contained therein, to read as follows:

Class "A/B-I" - 7

That the decrease in the number of Class "A/B-I" liquor licenses set forth in Section 1 above, is a result of Patan Inc. d/b/a Masala located at 801 E. Butterfield Road no longer conducting business at that location.

**Section 2:** That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor licenses contained therein, to read as follows:

Class "C" - 5

That the decrease in the number of Class "C" liquor licenses set forth in Section 2 above, is a result of Lombard BBQ Inc. d/b/a Firewater BBQ N Brew located at 440 E. Roosevelt Road voluntarily not renewing their liquor license for the January 1, 2020 licensing term.

**Section 3:** That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "V" liquor licenses contained therein, to read as follows:

Class "V" - 0

That the decrease in the number of Class "V" liquor licenses set forth in Section 3 above, is a result of Duafe I, LLC d/b/a 18/8 Fine Men's Salons-Lombard located at 314 Yorktown voluntarily not renewing their liquor license for the January 1, 2020 licensing term.

**Section 4:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
