**Liquor License Classification Changes** 

Please be advised liquor license holders with a Class "A/B" license are required to report their annual gross dollars of alcoholic liquor sales yearly. Two (2) of our liquor license holders require a change in their classification effective with the July 1 through the December 31 2020 licensing term:

Groundlevel 105, LLC d/b/a Groundlevel 105, located at 105 W. St. Charles Road, reported an increase in their 2019 sales which changes their classification from a Class "A/B-I" to a Class "A/B-II"; and

Greek Islander Restaurant d/b/a Greek Islands Restaurant, located at 300 E. 22<sup>nd</sup> Street, reported a decrease in their 2019 sales which changes their classification from a Class "A/B-III" to a Class "A/B II"

Attached is an Ordinance reflecting said changes effective July 1, 2020.

Please place this item on the May 21, 2020 Village Board of Trustees agenda for consideration.

Staff is requesting a waiver of first reading so that these liquor licensees are in the appropriate liquor classification for the July 1 through December 31, 2020 licensing term.

## AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That, effective July 1, 2020, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor licenses, contained therein, to read as follows:

Class "A/B-I" - 7

SECTION 2: That, effective July 1, 2020, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B II liquor licenses, contained therein, to read as follows:

Class "A/B-II" - 7

SECTION 3: That, effective July 1, 2020, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor licenses, contained therein, to read as follows:

Class "A/B- III" - 12"

SECTION 4: That the changes in the number of Class "A/B-II" and "A/B-III" liquor licenses set forth in Sections 1, 2 and 3 above are as a result of Groundlevel 105, LLC d/b/a Groundlevel 105, located at 105 W. St. Charles Road, reporting an increase in their gross dollars of liquor sales in calendar year 2019, resulting in a change from a Class "A/B-I" liquor licensee to a Class "A/B-II" liquor licensee and Greek Islander Restaurant d/b/a Greek Islands Restaurant, located at 300 E. 22<sup>nd</sup> Street, reporting a decrease in their gross dollars of liquor sales in calendar year 2019, resulting in a change from a Class "A/B-III" liquor licensee to a Class "A/B-II" liquor licensee.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
