AN ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE (ORDINANCE NO. 1186, "AS AMENDED" BY ORDINANCE NO. 7899) IN REGARD TO COMMUTER PARKING FEES

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of the appropriate signs as provided by law.
