## AN ORDINANCE GRANTING AN AMENDMENT TO ORDINANCE 4088 TO REINSTATE A CONDITIONAL USE FOR AN EXISTING DRIVE-THROUGH

(PC 20-23: 150 E. Roosevelt Rd, Smoothie King)

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, an application has heretofore been filed requesting approval of an amendment to Ordinance 4088 to reinstate a conditional use pursuant to the Lombard Zoning Ordinance (Title 15, Chapter 155 of the Village Code) for an existing drive-through, as set forth in Section 1 below; and,

WHEREAS, a public hearing on such application has been conducted by the Village of Lombard Plan Commission on October 19, 2020, pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of an amendment to Ordinance 4088 to reinstate a conditional use for an existing drive-through, to and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein;

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That an amendment to Ordinance 4088 to reinstate a conditional use for an existing drive-through, is hereby granted for the Subject Property legally described in Section 2, subject to the conditions set forth in Section 3.

**SECTION 2:** That this ordinance is limited and restricted to the subject property generally located at 150 E. Roosevelt Road, Lombard, Illinois, and legally described as follows:

THE NORTH 134.00 FEET OF THE SOUTH 184.00 FEET OF THE WEST 163.22 FEET OF THE EAST 193.22 FEET OF LOT 3 IN OWNER'S ASSESSMENT PLAT OF PART OF THE SOUTHWEST ¼ OF SECTION 17, TOWNSHIP 39 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED DECEMBER 20, 1943, AS DOCUMENT NUMBER 457027, IN DUPAGE COUNTY, ILLINOIS

**SECTION 3:** This Ordinance is approved subject to compliance with the following conditions:

- 1. That the petitioner shall develop the site in accordance with plans submitted as part of this
- 2. That the petitioner shall satisfactorily address all comments noted within the Inter-Departmental Review Committee Report; and
- 3. This relief shall be valid for a period of one year from the date of approval of the ordinance. If the drive-through is not established by said date, this relief shall be deemed null and void.

SECTION 4: This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
