Number of Authorized Liquor Licenses - Class "A/B-III"

Brio Tuscan Grille - 330 Yorktown

FoodFirst Global Restaurants, Inc. d/b/a Brio Tuscan Grille located at 330 Yorktown currently holds a Class "A/B-III" liquor license which allows them to serve alcohol as an adjunct to food service with no packaged sales. On June 17, 2021 staff received a letter indicating that the establishment is permanently closed and requested that their liquor license be terminated.

In response to that request as well as a result of their liquor license expiring on June 30, 2021, attached is an ordinance decreasing the Class "A/B-III" liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class "A/B-III" liquor classification current to reflect this change.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 11

Village Clerk

That the decrease in the number of Class "A/B-III" liquor licenses as set forth in Section 1 above, is a result of FoodFirst Global Restaurants, Inc. d/b/a Brio Tuscan Grille located at 330 Yorktown, no longer conducting business.

Section 2: This Ordinance shall be in full force and effect from and after its passage
