Subject: FY22 Vehicle Replacement, Tandem Axle Dump Truck

The FY 2022 budget includes replacement of Public Works tandem axle dump truck ST329. The replacement for ST329 will be equipped with a front plow, wing plow and salt spreader. These trucks are used for hauling large loads, plowing and salting operations. Since the lead time to build these trucks is approximately 10 months staff would like Village Board authorization to place the order for the vehicles now.

Public Works has a standard set of specifications for these trucks which includes a Peterbilt chassis outfitted with a Monroe dump body, salt spreader and plows. The Peterbilt chassis is available for joint purchase through Sourcewell (formerly NJPA) contract #060920-PMC. The participating Sourcewell Peterbilt dealer in our area is JX Peterbilt of Bolingbrook, IL. The dump body, plow and salt spreader are also available for joint purchase through the Sourcewell contract #080114-MTE. The participating Sourcewell vendor for this equipment is Monroe Equipment of Joliet, IL. The price of the Street Division truck outfitted with the above equipment is \$244,793.64. The amount in the 2022 budget for this purchase is \$255,000.

I recommend the Board of Trustees waive bid and award a contract to JX Peterbilt of Bolingbrook, IL in the amount of \$244,793.64 for a new Peterbilt dump truck equipped per the Village specifications. I also recommend declaring Village unit numbers ST329 as surplus per the attached ordinance and authorizing their sale at public auction. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the July 15, 2021 meeting.
