### 170196 Presentation - American Heart Life Saving Award

Fire Chief Richard Sander spoke of the Fire Department having two cardiac arrests within one hour of each other on February 6th and how both patients were doing well due to the quick responses of bystanders, use of AED and the quick responses of both the Police and Fire Departments.

Lt. Frank Gallione proceeded to provide information on both cardiac arrests - one at X-Sport Fitness and one at the Lombard Police Department - within one hour of each other and how bystanders who were willing to jump in and begin CPR and use an AED helped save the lives of these two individuals until the Paramedics arrived to continue treatment and transport each of the patients to the hospital. He spoke of the 3-5 minutes following the cardiac arrests and how important it was to the outcome for the patients because bystanders jumped in and began treatment until the Paramedics arrived. Awards were given to the X-Sport Fitness staff and to the Paramedics. Lt. Gallione noted that the Village has received awards for excellence for cardiac care.
