At last Mondays Economic and Community Development Committee meeting, the following actions were taken:

Hoffmann Group/Northern Seminary Redevelopment

Staff introduced an economic incentive discussion associated relative to the former Northern Theological Seminary property at 600 E. Butterfield Road. With the proposed redevelopment of the property as a mixed-use commercial site, which will include Golf Social, Morettis fuel center and residential components, the ECDC discussed general parameters of the Villages previously adopted Economic Incentive Policies. The ECDC provided direction to staff accordingly on possible incentive parameters of an Agreement, if warranted.

**Humane Animal Ordinance Discussion**
