| Title:         | Ordinances Amending the Lombard Village Code-Title 5, Chapter 51, Section 51.10 in Regard to<br>Water Meters and Title 5, Chapter 50, Section 50.114 in Regard to Water Rates<br>Two (2) Ordinances Amending Title 5, of the Lombard Village Code in Regard to Adding an<br>Administration Service Charge of \$35.00 per Billing Period for Customers That Choose to Opt-out of<br>Having the Required Remote Water Meter Reading Device.<br>1. AN ORDINANCE AMENDING TITLE 5, CHAPTER 51, SECTION 51.10 OF THE LOMBARD<br>VILLAGE CODE IN REGARD TO WATER METERS<br>Effective January 1, 2020, this ordinance amends Section 51.10(C) to remove the name of the water<br>meter manufacturer and adds a new Section 51.10(G) to establish a flat fee of \$35.00 per billing<br>period fee for customers that choose to opt-out of having the required remote water meter reading<br>device installed.<br>2. AN ORDINANCE ADDING TITLE 5, CHAPTER 50, SECTION 50.114 OF THE LOMBARD<br>VILLAGE CODE IN REGARD TO WATER RATES<br>Effective January 1, 2020, this ordinance adds a new Section 50.114(E) to establish a flat fee of<br>\$35.00 per billing period as an administrative service charge to cover the Village's administrative<br>expenses relating to providing for manual water meter reading and manual entry of water<br>consumption for billing purposes, subject to a medical reasons fee waiver provision.<br>The Public Works & Environmental Committee unanimously recommended to the Village Board<br>approval of the attached Ordinances on waiver of first reading. |           |                 |       |              |   |      |
